Regional Director/Deputy Director/Assistant Director, WCS Asia Program: 2005-2017.

Provided supervision and support to Wildlife Conservation Society (WCS) country programs and projects in Russia (including programs in Arctic Beringia and the Russian Far East), China, Mongolia, Afghanistan, Pakistan, Iran, Kazakhstan, Tajikistan, Kyrgyzstan, Uzbekistan, Fiji, and Papua New Guinea; responsible for overseeing roughly 150 staff in the region. Identified new landscapes and species conservation opportunities, designed new programs and projects, established conservation priorities, and provided guidance to project development and implementation. This includes the creation and management of four new country programs (Pakistan, Mongolia, Afghanistan, and Arctic Beringia) and providing technical advice on field research, monitoring, protected area creation and management, anti-poaching and wildlife trafficking mitigation, community-led conservation initiatives, policy, and conservation education efforts aimed at both community outreach and school-based curriculum.

Managed the Wildlife Conservation Society (WCS) Graduate Scholarship Program and the WCS Research Fellowship Program, and chaired the executive committee for the Conservation Leadership Program (CLP, a partnership between WCS, FFI, and BirdLife). This includes designing new initiatives, raising funds, managing a budget of approximately \$5 million, managing the review process, overseeing the grant decisions, partnering with universities, and providing direct support to scholars and grantees. Among other outcomes provided 5-8 graduate scholarships a year (~100 total) to young conservation leaders in the developing world to receive Masters or PhDs at top-flight universities around the world.

WCS Afghanistan Country Program Director – 2006 – Kabul, Afghanistan: Designed, opened, and led the USAID-funded project "Biodiversity Conservation in Afghanistan." Designed the program, wrote the project proposal, hired staff, developed budgets and workplans and assisted in the implementation of the 14 project components with ~70 staff. These included wildlife and rangeland surveys, community led conservation, developing the country's first eight environmental laws and regulations, training and capacity building, helping create Afghanistan's first two protected areas, including Band-e-Amir and Wakhan National Parks, and designing a four-country transboundary protected area in the Pamirs between Afghanistan, Pakistan, China, and Tajikistan. Arranged follow-on funding from USAID (total \$24.8 million) and GEF (\$7.4 million). Continued supervising the program through 2018.
